The regular City Council meeting was called to order by Mayor Russ Myran.

The minutes of the September 2, 2014 regular City Council meeting were approved as read.

Gayle Elkins asked about a meter being read correctly and if it will be fixed. She also inquired about gutters being cleaned. City maintenance would take care of the issues.

The street sealing project will need to be completed. Contractor for the lagoon will be contacted for a progress report.

One bid was submitted for snow removal. Jurgens Trucking submitted a rate of \$115/Payloader and Bobcat \$75.00. Aaron Gjermundson moved, seconded by Ron Luff, motion carried unanimously.

Dump ground will be closed for the winter on October 15, 2014.

Jeremy Wood with Northern Plains Engineering presented a proposed lagoon expansion. Tabled pending land availability.

City Attorney was present regarding city ordinances. An update will need to be published in the Richardton Merchant.

The September financial statement was accepted as presented.

2015 Final Budget adjustments will reflect an increase to \$5000 to the Attorney fees as well as Municipal Judge will be changed from \$0 to \$2500. Ron Luff moved to approve with changes, seconded by Aaron Gjermundson, motion carried unanimously.
